General Information - Filing Requirements

DO NOT FILE THIS FORM IF YOU HAVE NOT PREVIOUSLY FILED A COMPLETE STATEMENT OF FINANCIAL INTERESTS ON NADC FORM C-1 WITH THE COMMISSION

I. Who Should File:

- A. 1. A member of the board of directors or an officer of a district organized under the provisions of Chapter 70, Revised Nebraska Statutes (public power districts and rural power districts).
2. A member of a land-use planning commission, zoning commission, or authority of the State or any county with a population of more than 100,000 inhabitants.
3. An elected official of a city of the primary or metropolitan class.
4. An elected county official (county commissioners, supervisors, weed board members, attorney, sheriff, register of deeds, clerk, clerk of the district court, superintendent of schools, engineer, assessor, public defender, treasurer, surveyor).
5. Other officials or employees of the state designated by Commission Rule 2.

II. When and Where to File:

- A. All officeholders and state employees specified above should file with the Commission annually by April 1 and with the election commissioner or clerk of the county of their residence within 5 days of filing with the Commission.
- B. Candidates for the elective offices and positions specified above should file with the same official with whom the candidate files to run for office at the time of filing for office. (A candidate's filing for office will not be accepted unless accompanied by a Statement of Financial Interests.) The candidate should file the same statement with the Commission within 5 days of filing for office. In addition, if the candidate has not already filed a copy of the Statement with the election commissioner or county clerk of the candidate's residence, he should do so within 5 days of filing with the Commission. (Note: This does not apply to a person who has already filed a Statement for the preceding calendar year.)

Candidates who file to appear on the ballot for election prior to January 1 of the year in which the election is held must file a supplementary statement on or before April 1st of the year in which the election is held.

- C. If newly appointed to an office specified under 1-A, the appointee should *not* file on this form. A complete NADC Form C-1 (Statement of Financial Interests) should be filed with the Commission **before assuming the duties** of office and with the election commissioner or the county clerk of the county of the appointee's residence within 5 days of filing with the Commission. If confirmation is required, also file with the official or body acting on confirmation within 15 days after nomination or 10 days before action on the nomination, whichever is sooner.
- D. Within 30 days after leaving an office or a position specified under 1-A, a Statement should be filed with the Commission and with the election commissioner or clerk of the county of the filer's residence, covering the period from the end of the calendar year for which you previously filed to the date you left office.

III. Potential Conflict of Interest Filings

The individuals listed under 1-A above are also required to file a Potential Conflict of Interest Statement (NADC Form C-2)) whenever a potential conflict arises. A potential conflict of interest exists when such official or employee, in the discharge of his or her official duties, would be required to take an action or make any decision that may cause financial benefit or detriment to him or her, a member of his or her immediate family, or a business with which he or she is associated which is distinguishable from the effects of such action on the public generally, or a broad segment of the public.

Instructions for Item 5

Review the last Statement of Financial Interests that you filed on the long form (NADC Form C-1). If you are unable to review the last Statement of Financial Interests you filed on the long form, you may not use this form (NADC Form C-1A). If there is no change in the information reported on your last long form and the information you must disclose for this reporting period, check the box marked NONE. If there is information not shown on your last long form, but which you must report for this reporting period, check the box marked ADD. If there is information on your last long form which should not be reported for this reporting period, check the box marked DELETE. If there is any other change in the information reported on your last long form and the information which you must report for this reporting period, check the box marked CHANGE. If you mark the ADD, DELETE, or CHANGE boxes you must describe the additional, deleted or changed information on a separate sheet and attach it to this report.
